On this day of _____, an agreement of temporary co-ownership of the above mentioned bitch has been entered into in good faith by _____, hereafter referred to as buyer and Diane Wright.

Purchase price will be, _____ plus an agreement of breeding rights retained by Diane Wright, as indicated in the following sections of this contract. Buyer agrees to abide by the Keeshond Club of America Code of Ethics, which is attached to and made part of this contract.

The following are the terms of this sale and temporary co-ownership:

Achieving this bitch's championship title will be the buyer's first priority. All attempts to campaign this bitch to her championship title (AKC conformation title) will be made by the buyer. All expenses for the above mentioned bitch will be the sole responsibility of the buyer: these expenses include but are not limited to all maintenance, veterinary, grooming and all expenses associated with showing this bitch.

Breeding of this bitch will only occur under the following terms:

She must remain breeding quality, to be determined by breeder. (s) She must have been shown actively prior to breeding. She must have at least had preliminary hip x-rays and stifles checked at one year of age, pronounced clear by a veterinarian. She must be in good health.

Diane Wright and buyer are to agree on potential stud dogs. Stud fees and any other fees associated with the breeding will be the sole responsibility of the buyer. Each puppy produced by this bitch will be sold with a limited registry, pet/spay/neuter contract or full registry with a breeding/show contract. Diane Wright will co-own this bitch and be the co-breeder of her first litter. Diane Wright will have her choice of one puppy in the litter. This puppy will carry the Jen'nDi kennel name only with no strings attached by the buyer. Adequate means to make this choice must be provided to Diane Wright. Shipping fees of Diane Wright's puppy if applicable will be the responsibility of Diane Wright. If only one-puppy results from this litter Diane Wright, under consideration of the buyers wishes, may pass on this litter and terms will apply to the next litter.

Other terms of breeding contract:

In the event this bitch reaches two years of age and Diane Wright agrees or decides that the bitch has not matured to breeding quality, the bitch will be immediately spayed. Diane Wright will return monies to the buyer less current pet price, or buyer has the option to buy a second show prospect at pet price.

Buyer understands that a Keeshond is above and beyond all a companion and should be given ample attention by its humans. Buyer agrees to love, train, and groom this bitch. Buyer agrees to act in this bitch's best interest and keep her in good health, current on all shots and free from worms.

In the event the buyer is unable to uphold his or her commitment to this bitch, Diane Wright retains first right of refusal and said bitch will be returned to Diane Wright unaltered.

All parties agree to uphold the terms of this contract in full.
