On this day of _____, an agreement of temporary co-ownership of the above mentioned dog, has been entered in good faith by _____, hereafter referred to as buyer, and Diane Wright. Attached to and made part of this contract is a copy of the Keeshond Club of America Code of Ethics.

Purchase price will be: _____ plus an agreement of breeding rights retained by Diane Wright as indicated in the 'breeding terms' section of this contract. Cash price will be paid in full before shipping or delivery of puppy.

The following are the terms of this sale and temporary co-ownership.

All expenses for the above mentioned dog will be the sole expense and responsibility of the buyer. Expenses include but are not limited to all maintenance, veterinary, grooming, and all showing expenses. This dog is being sold as a breeding/ show prospect. All attempts to campaign this puppy or dog to his AKC conformation championship title will be made by the buyer. Achieving this title will be considered a high priority to the buyer.

Breeding of this dog will occur only under the following terms;

He must first remain breeding quality to be determined by breeder (s). He must have been shown actively prior to breeding. He must at least have had a preliminary hip x-ray and stifles checked at one year of age pronounced clear by a vet. All puppies produced by this dog will be sold with contracts, be they full registry, show/breeding contracts or limited registry, pet/ spay/ neuter contracts.

Diane Wright retains the option of _____ breedings from the above-mentioned dog to a bitch or bitches of Diane's choice resulting in puppies on the ground.

Other terms of breeding contract: _____

This dog will be co-owned by buyer and Diane Wright until he has achieved his AKC championship title and breeding terms have been worked out. After such time the buyer will become the sole owner of this dog.

Diane reserves the right to decide if this dog has or has not reached his potential, and has remained breeding/ show quality or not. In the event that this dog reaches maturity and has not remained show quality by owner's evaluation Diane will evaluate the puppy and decide if she wants the puppy returned to her intact. No cash money will be refunded but a show puppy will be replaced to owner when one becomes available. In the event this dog reaches two years of age and Diane Wright agrees or decides he has not matured to breeding quality, the dog will be immediately neutered. Diane Wright will return monies to the buyer less current pet price or the buyer has the option to buy a second show prospect at pet price.

The buyer understands that a Keeshond is above and beyond all a companion and should be given ample attention by its humans. Buyer agrees to love, train, and groom this dog. Buyer agrees to act in the best interest of this dog and keep him in good health, current on all shots and free from worms.

If for any reason the buyer cannot fulfill his or her commitment to this dog, Diane Wright retains the first right of refusal.

All parties agree to uphold the terms of this contract in full.
